DECISION

Motion for *Pro Hac Vice* Admission

As authorized by the Notice of Filing Date Accorded to the Petition (Paper 7<sup>1</sup>), Paice LLC and The Abell Foundation, Inc. (collectively, “Patent Owner”) filed a “Motion for *Pro Hac Vice* Admission” (Paper 14, “Mot.”) of Daniel A. Tishman.<sup>2</sup> Patent Owner is expected to continue to have a registered practitioner as lead counsel. Ford Motor Company (“Petitioner”) does not oppose Patent Owner’s Motion. Mot. 2. It is

ORDERED that Patent Owner’s Motion for *pro hac vice* admission is *granted*, and Mr. Tishman is authorized to represent Patent Owner as back-up counsel in IPR2015-00758, IPR2015-00784, IPR2015-00787, IPR2015-00790, IPR2015-00791, IPR2015-00792, and IPR2015-00799;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner as lead counsel in these *inter partes* review
