PETITIONERS' REQUEST FOR ORAL ARGUMENT

Pursuant to 37 C.F.R. § 42.70(a) and the Board’s Scheduling Order (Paper No. 20) and Update to Scheduling Order (Paper No. 36), Google Inc. and Samsung Electronics Co., Ltd. (“Petitioner”) respectfully submit this Request for Oral Argument. As set forth in the Update to Scheduling Order, the Board has scheduled oral argument for May 18, 2016. (*Id.*)

Petitioner specifies the following issues to be argued:

- The unpatentability of claims 12, 13, 16, 18, 19, 21, 22, 23, 24, 25, 35, 36, 37, 38, 40, 41, 42, 44, 45, 46, and 49 under 35 U.S.C. § 103 in view of:
 - Exhibit 1004, U.S. 6,930,709 to Creamer et al. (“Creamer”) in view of Exhibit 1005, U.S. 6,223,190 to Aihara et al. (“Aihara”); and
 - Exhibit 1006, U.S. 6,018,774 to Mayle et al. (“Mayle”) in view of Exhibit 1007, U.S. 6,035,323 to Narayen et al. (“Narayen”)
- Patent Owner’s failure to present sufficient objective evidence of secondary considerations of nonobviousness, and failure to establish a nexus;
- Petitioner’s Motion to Exclude Evidence;
- Any other issues identified by Patent Owner for oral argument or any other issues raised in papers yet to be filed; and

• Any other issues the Board deems necessary for issuing a final written decision.

Petitioner requests a podium and permission to use audio/visual equipment at the oral argument, including a projector and screen for displaying evidence or demonstrative exhibits.
