A Court can prevent a party from asserting 3 inconsistent positions under the doctrine of judicial 4 5 estoppel. In addition, Defendant's Exhibit No. 2029 would also 6 7 be admissible as non-hearsay because defendants should be 8 permitted to offer it to show Plaintiff's notice of the potential prior use of the invention claimed in the Point2 9 '802 Patent and how that notice affected Plaintiff's 10 subsequent conduct regarding the acquisition of the Point2 11 '802 Patent.
