Q When is the document considered published by the IETF? A The IETF considers it published on the date the announcement is sent. It's possible that it may be in a public repository a day or two before that, but it's considered when the announcement is sent, because that's when people know it's there. Q And who has access to the repository? A Everyone. Anyone who has access to the Internet. Q So a member of the public could go on the Internet and search for a particular RFC and be able to see that? A Yes. Q Do you know how far back the records go?
