Petitioner requests permission to argue first. *See* Office Patent Trial Practice Guide, 77 Fed. Reg. 45,756, 48,768 (Aug. 14, 2012). Petitioner also requests forty-five minutes for argument, with the opportunity to reserve time for rebuttal.

Petitioner further requests that audio/visual equipment be made available to display demonstrative exhibits during the oral argument, including a projector,



ELMO, and screen.

Petitioner also requests the services of a court reporter to transcribe the proceeding.
