# Topics Not Permitted for Discussion

- Conditions that PROLENSA is not indicated to treat but may be elated to the off-label use of NSAIDs, such as
- Cystoid Macular Edema, Diabetic Macular Edema, Macular Edema
- Miosis
- the role/use of NSAIDs in surgeries other than cataract surgery (e.g. PRK and LASIK)
- Administration or use of PROLENSA that is not within labeled directions - e.g. dosage variations, etc
- Any other off-label topics that relate to the use of PROLENSA or other Bausch + Lomb pharmaceutical products
