**A. 37 C.F.R. § 42.8(b)(2): Related Matters**

**(1) Status of litigations related to this proceeding**

Patent Owner Senju Pharmaceutical Co., Ltd., Bausch & Lomb, Inc., and Bausch & Lomb Pharma Holdings Corp. (collectively, “Patent Owner”) filed two complaints for patent infringement arising from the filing of Paragraph IV Certifications against U.S. Patent No. 8,129,431 (“district court action”). One district court action was filed against Innopharma Licensing, Inc., Innopharma Licensing, LLC, Innopharma, Inc. and Innopharma LLC in the U.S. District Court for the District of New Jersey on November 3, 2014 (Case No. 1:14-cv-06893), and the other district court action was filed against Lupin Ltd. and Lupin Pharms., Inc. on January 31, 2014, also in the United States District Court for the District of New Jersey (Case No. 1:14-cv-00667). A bench trial in the above-referenced cases was held before the Honorable Jerome B. Simandle from April 4, 2016 through April 12, 2016 (specifically on April 4, 5, 6, 11, and 12, 2016), and the trial transcript is combined and filed as Exhibit 2277. Post-trial Proposed Findings of Fact and Conclusions of Law are due on May 12, 2016, with responses due on May 26, 2016. Post-trial briefs are also due on May 12, 2016, with no responses. Closing arguments are expected to be heard approximately 14 days after final submissions, at a date and time to be set by the Court.
