Bausch + Lomb Announces 2016 Launch of Bausch + Lomb Ultra Contact Lenses for Presbyopia

Bausch + Lomb announced that Bausch + Lomb ULTRA contact lenses for Presbyopia will become available during the second quarter of 2016. The new multifocal lens was specifically designed to combine the company's 3-Zone Progressive design, found in Biotrue ONEday for Presbyopia daily disposable contact lenses, with the end-of-day comfort of Bausch + Lomb ULTRA contact lenses with MoistureSeal technology. Bausch + Lomb ULTRA contact lenses with MoistureSeal Technology contain polyvinylpyrrolidone (PVP) for enhanced wettability and have the highest Dk/t (163) and lowest modulus (70) compared to the silicone hydrogel contacts lenses in the market. The lens also has aspheric optics, for exceptional vision even in low light conditions.

Bausch + Lomb's Adjustable Chandelier Fiber for the Stellaris PC Vision Enhancement System Receives FDA Clearance

Bausch + Lomb announced that 510(k) clearance has been received from the U.S. Food and Drug Administration (FDA) for an adjustable chandelier fiber optic illuminator in 23- and 25-gauge versions, which has been designed specifically for the Stellaris PC Vision Enhancement System. The adjustable chandelier

will deliver surgeons with uniform, diffused lighting and modifiable light control to help provide excellent intraocular visibility and efficiency during vitreoretinal procedures. The device will also provide Stellaris PC users the following additional features including: Controlled Light Adjustment: Surgeons can easily fine-tune the degree of light in the eye without directly modifying the machine settings or breaking focus from the patient by adjusting the available slider. Adjustable Fiber: The flexible cable allows surgeons to manage light intensity for optimal illumination, without removing the fiber from the valved cannula. The optical fiber tip is designed to extend into the eye for a controlled yet minimal distance for optimal placement and illumination yet away from the lens. Secure Placement: The distal fiber is designed to friction fit within the valved cannula to prevent inadvertent disconnection during surgery, yet allows controlled removal and relocation. 90degree Distal Curvature: Designed to facilitate placement around the eye.

Bausch + Lomb Announces 23-Gauge Fragmentation Needle Availability for Stellaris PC Vision Enhancement System

Bausch + Lomb announced the availability of a 23-gauge fragmentation needle for the Stellaris PC Vision Enhancement System. This new ultrasonic needle design is used during vitreoretinal procedures to effectively remove the lens material from the posterior chamber of the eye with balanced irrigation and aspiration through 23-gauge incisions providing enhanced intraoperative control and efficiency. Prior to its introduction, surgeons were required to use larger fragmentation needles in order to remove lens fragments during surgery, thus necessitating the need for increased incision size, suturing of the wounds and lengthened recovery time. Surgeons are now able to utilize the 23-gauge fragmentation needle to help balance the inflow and outflow in the eye and achieve a suture-less wound closure. When combined with the Stellaris PC with 23-gauge valve Entry Site Alignment system, this advancement will provide surgeons: Use of the existing cannula wound architecture to insert the 23-gauge fragmentation needle into the eye; Fluidic and intraocular pressure stability during lens nucleus removal, due to the consistency in gauge sizes for inflow and outflow of fluid. Easy replacement of the original valved cannula in the same wound for completion of the procedure.
