**PETITIONERS' UPDATED MANDATORY NOTICES  
AND NOTICE OF RELATED FEDERAL CIRCUIT DECISION**

<sup>1</sup> Apple Inc. and Black Swamp IP, LLC, which filed petitions in IPR2016-00063 and IPR2016-00167, respectively, have been joined as Petitioners in the instant proceeding.

Petitioners submit the following update to their Mandatory Notices to inform the Board about developments in a related matter. *See* 37 C.F.R. § 42.8.

On August 19, 2021, the Federal Circuit remanded Patent Owner VirnetX Inc.’s appeal in this proceeding “for the limited purpose of allowing VirnetX the opportunity to request Director rehearing of the final written decisions.” *VirnetX Inc. v. Mangrove Partners Master Fund*, Appeal No. 2020-2271, Dkt. No. 51 (Fed. Cir. Aug. 19, 2021). “VirnetX must file the request for rehearing within 30 days from the date of” the August 19, 2021 order. *Id.* The Federal Circuit “retain[ed] jurisdiction” over the appeal and ordered Patent Owner to inform the Federal Circuit “within 14 days of any decision denying rehearing,” such that “[t]he Clerk of Court shall reactivate” the appeal “upon receipt of that notice.” *Id.*

Petitioner Apple Inc.’s appeal of the jury verdict in *VirnetX Inc. v. Apple Inc.*, No. 6:12-cv-00855-RWS (E.D. Tex.), which also involves the ’151 patent, “will proceed in the normal course.” *Id.*
