



- Approximately 6 million ocular anti-inflammatory prescriptions (steroid and NSAID) were written for post surgery in 2011
- 3.5 million cataract surgeries are projected for 2013²
- Although surgeries have advanced to be minimally invasive, some degree of postoperative inflammation is still unavoidable3
- Direct ocular manipulation causes the release of prostaglandins and other inflammatory
- NSAIDs are commonly used to treat postoperative inflammation and reduce mediators from the iris and ciliary body

Anti-inflammatory agents post surgery allow for more rapid resolution of inflammatory symptoms⁴
