## Disease State Overview

- Approximately 6 million ocular anti-inflammatory prescriptions (steroid and NSAID) were written for post surgery in 2011
  - 3.5 million cataract surgeries are projected for 2013<sup>2</sup>
- Although surgeries have advanced to be minimally invasive, some degree of postoperative inflammation is still unavoidable<sup>3</sup>
  - Direct ocular manipulation causes the release of prostaglandins and other inflammatory mediators from the iris and ciliary body
- NSAIDs are commonly used to treat postoperative inflammation and reduce ocular pain
- Anti-inflammatory agents post surgery allow for more rapid resolution of inflammatory symptoms<sup>4</sup>

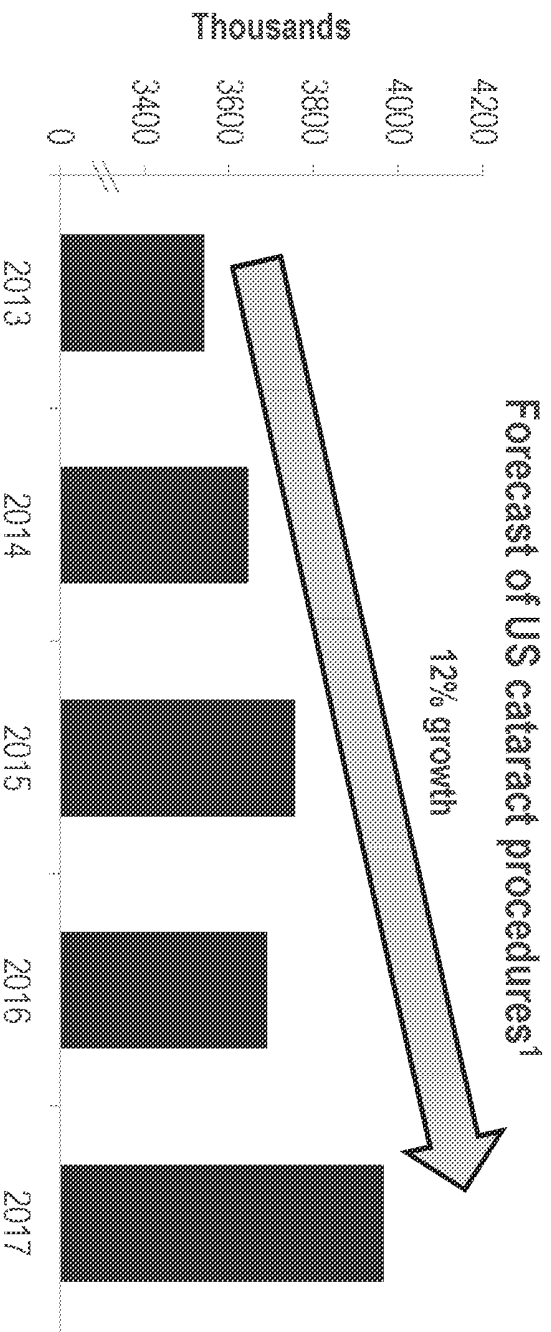

# Cataract Procedures



- The US population aged 65 years and older increased from 35 million in 2000 to 40 million in 2010 (a 15% increase) and is estimated to reach 55 million by 2020 (a 36% increase). By 2030, the elderly population will reach 72.1 million—almost twice the number in 2007 and roughly 20% of the US population<sup>2\*</sup>
