- (3) Whether the Petitioner has met its burden to show that claims 2 and 9 of the '012 Patent would have been obvious over Brusilow '91 in view of Sherwin '19, Shiple, and the '647 Patent.
- (4) Whether the Petitioner has met its burden to show that claims 6 and
  11 of the '012 Patent would have been obvious over Brusilow '91 in
  view of Sherwin '19, Shiple, Kasumov, and the '979 Patent.
- (5) Claim interpretations and any other subsidiary issue relevant to issues(1) (4).
- (6) The Patent Owner's responses to arguments made by the Petitioner in the Reply (Paper 30) filed May 27, 2016.

- (7) Any other issues identified by the Patent Owner for oral argument or any other issues raised in papers yet to be filed.
- (8) Any other issues the Board deems necessary for issuing a final written decision.
