4	afternoon for oral arguments in Inter Partes Review matter
5	number IPR2015-01341. The case in which Boeing Company
6	is the Petitioner and Seymour Levine is the Patent Owner.
7	The Panel for the hearing today is my colleague,
8	Judge Kim, sitting here to my right; myself, Judge Ward; and
9	Judge Fishman joining us on screen here from our regional
10	office in Denver, Colorado.
11	Good afternoon, Judge Fishman. Can you hear us
