

#### I. Statement of Precise Relief Requested

Pursuant to 37 C.F.R. §§ 42.6(d) and 42.7, Patent Owner Energetiq Technology, Inc. ("Energetiq") requests that the Board expunge Exhibit 2066 and replace it with the attached Replacement Exhibit 2066.
