[57] ABSTRACT

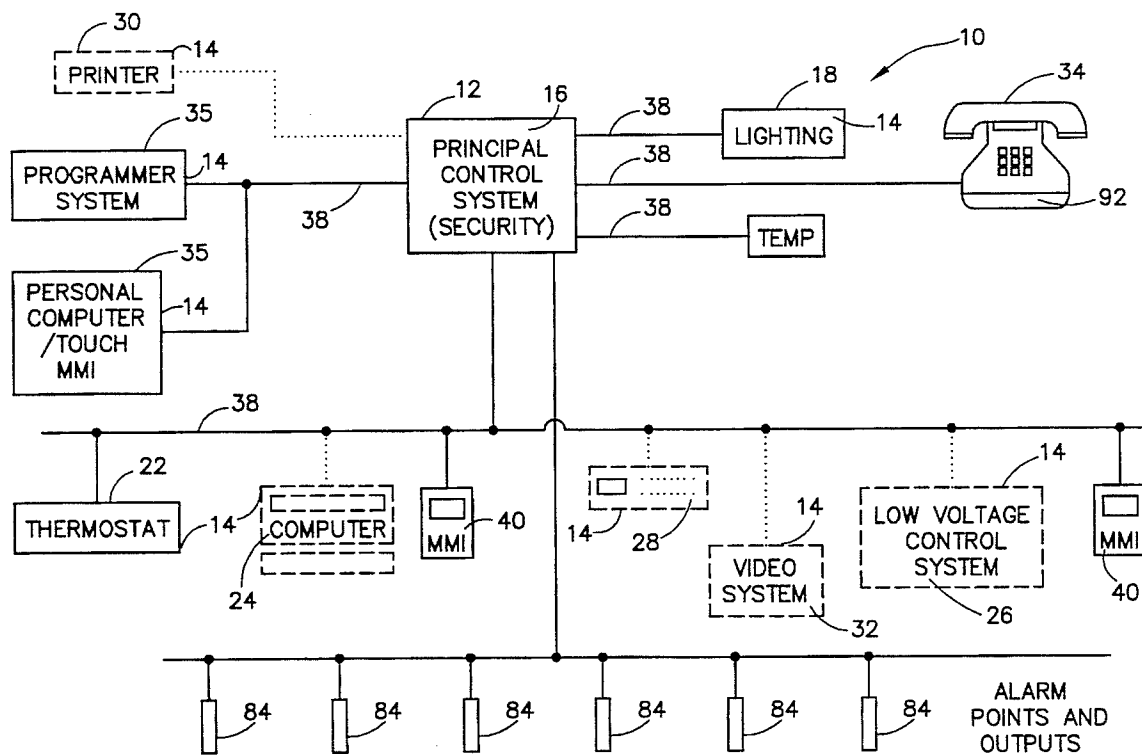
A system and method for modifying security levels within a security system. External modifications are allowed only if the security of a point is increased.

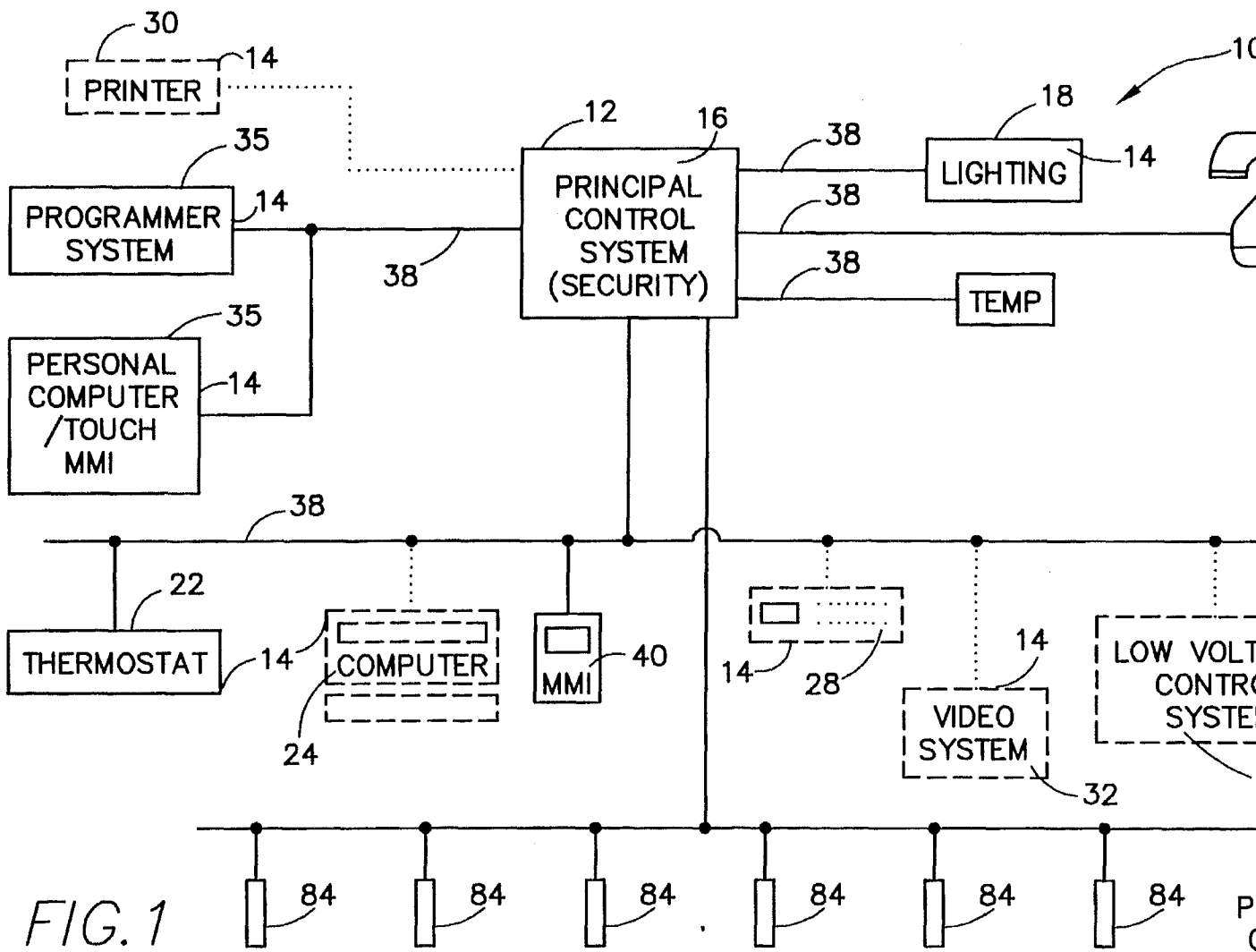

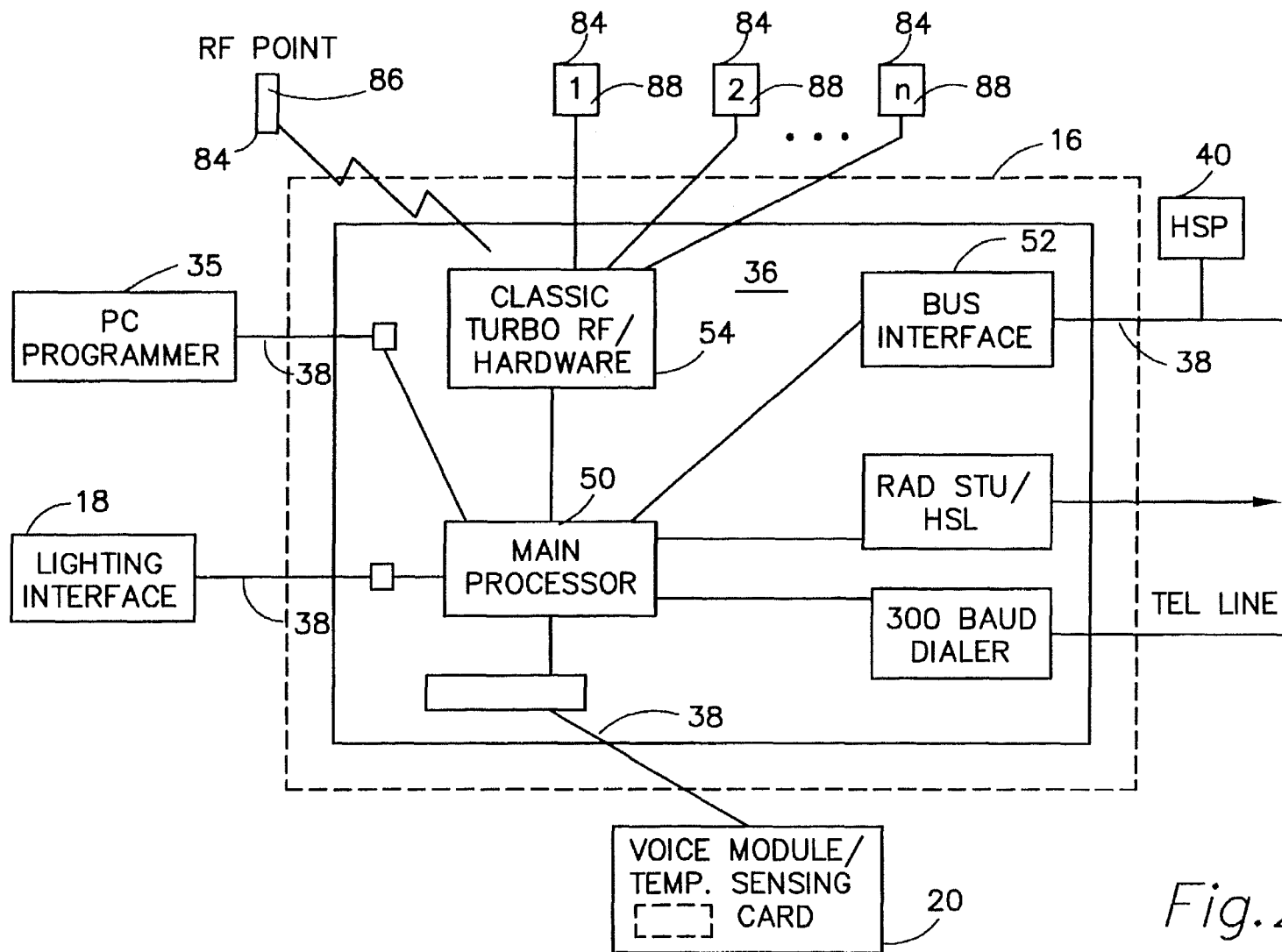

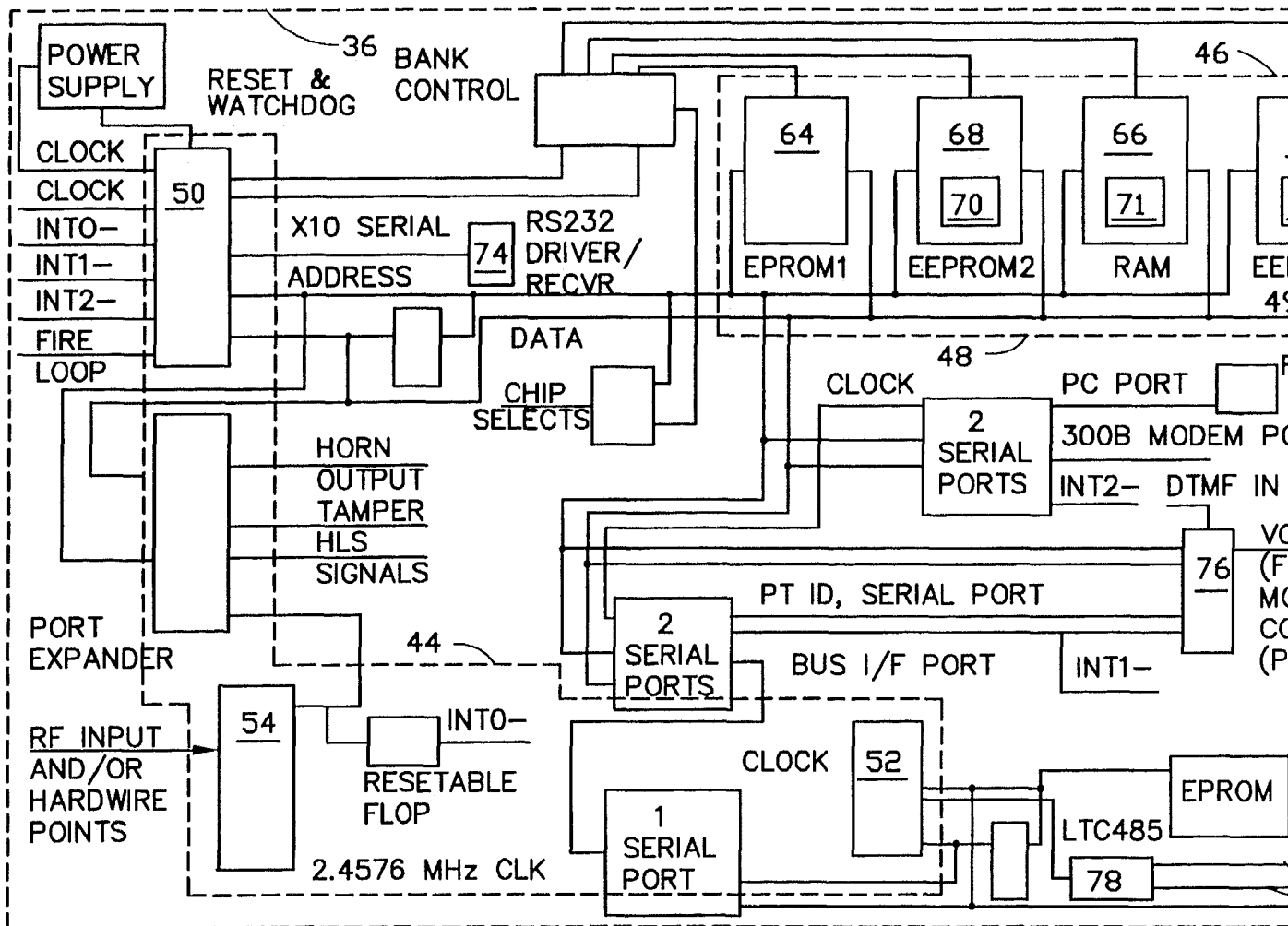

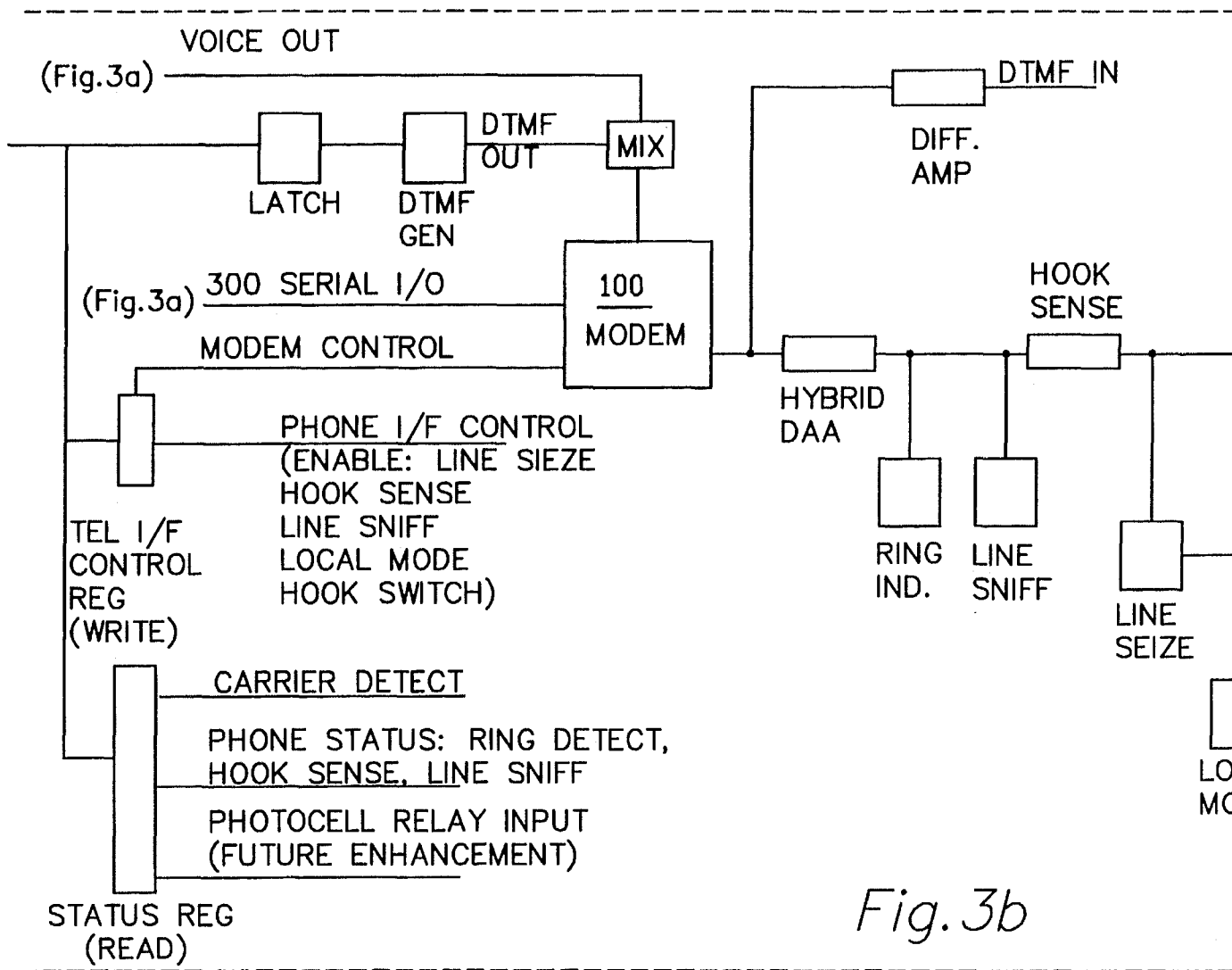
