3. The unpatentability of claims 17 and 47 in view Groman (Ex. 1004) and Geisser (Ex. 1003).

4. The unpatentability of claims 1, 14 and 15 in view of van Zyl-Smit (Ex. 1006).

5. The unpatentability of claim 30 in view of van Zyl-Smit (Ex. 1006) and Funk (Ex. 1026).

6. The arguments, including the arguments regarding the unpatentability of Patent Owner's proposed substitute claims, presented in Petitioner's Opposition to Patent Owner's Motion to Amend and Sur-reply.

7. Any other issues that the Board deems necessary for issuing a final written decision.

screen for displaying documents.
