

## HISTORY

- Westfalia Separator
  - Late 2007 installation, early 2008 planned startup
  - Second installation for oil recovery
  - Built Westfalia P&ID: No oil recovered!
  - Spin test: No "free" oil
  - Westfalia: "You must have changed your process."
- BEST Energies

- Need to disrupt the oil-in-water emulsion
- Time and Temperature approach
- Batch operations during reenginering

## INITIAL SOLUTION

- Heat syrup from 140 °F to 190-192 °F
  - Lower temperature decreases oil yield
  - Higher temperature darkens DDGS
- Increase residence time to 20 hours
  - Lower residence time decreases oil yield
  - Higher residence time is infeasible without \$
- Result: 0.25 lb Oil / bu Corn
