The 059 patent was the subject of an interfering patents action filed by Superior Oil Company, Inc. against Solenis Technologies L.P. (Case No. 1:15-cv-00183-GMS, District of Delaware), involving the 059 patent and U.S. Patent No. 8,841,469 ("the 469 patent"). That action was dismissed with prejudice on June 11, 2015. The 059 patent and the 469 patent are now commonly owned by Solenis Technologies, L.P.

Hydrite Chemical Company filed a petition for *inter partes review* against the 469 patent (Case IPR2015-01586) as well as a concurrent declaratory judgment action in the Eastern District of Wisconsin, 2-15-cv-00856, on July 14, 2015.
