Genentech, Inc., City of Hope, Sanofi-Aventis U.S. LLC, Regeneron Pharmaceuticals, Inc., and Genzyme Corporation, by and through their respective counsel of record, have stipulated as follows:

1. On February 5, 2016, the Patent Trial and Appeal Board issued a Scheduling Order (Paper No. 16) in the *Inter Partes* Review of U.S. Patent No. 6,331,415 (Trial No. IPR2015-01624) setting forth due dates “for the parties to take action after institution of the proceeding.” Paper No. 16 at 2.
