JUDGE WEIDENFELLER: Thank you.

So the purpose of this conference call is to address Petitioner's request regarding the destruction of certain documents that were produced to Patent Owner under our protective order.

MR. GIUNTA: Thank you, Your Honor.

So RPX provided highly sensitive confidential -- confidential information to AIT solely for use in these proceedings. The protective order acknowledgement that AIT signed acknowledges that AIT would, quote, use the confidential information only in connection with this proceeding and for no other purpose, end quote.

These proceedings are over, and the time for appeal expired on January 29th. There is no legitimate reason for AIT to retain RPX's confidential information. AIT -- AIT cannot use it now or any time in the future without violating the protective order acknowledgement that they signed acknowledging that they would use it for no other
