The above-identified proceedings are on remand from the U.S. Court of Appeals for the Federal Circuit. Petitioner filed a motion with the U.S. Court of Appeals for the Federal Circuit to recall the mandate, vacate the Court's judgment, and reinstate the appeal for a merits decision. *See* Ex. 1103.² Pursuant to our authorization, Petitioner filed a Motion to Stay the above-identified proceedings pending a decision from the Federal Circuit on Petitioner's motion to recall the mandate. Paper 118. Patent Owner also filed an Opposition. Paper 120. Thereafter, the Federal Circuit denied Petitioner's motion to recall. *See* Ex. 3004. Accordingly, Petitioner's Motion to Stay is moot, and we dismiss the motion.

Accordingly, it is:

ORDERED that Petitioner's Motion to Stay is *dismissed as moot* in each of IPR2015-01750, IPR2015-01751, and IPR2015-01752.
