ORDER  
Granting Petitioner's Revised Motion for Admission  
*Pro Hac Vice* of Talin Gordnia  
37 C.F.R. § 42.10

Petitioner filed a revised motion for *pro hac vice* admission of Ms. Talin Gordnia on May 17, 2016. Paper 14. Petitioner represents that Patent Owner does not oppose the motion. Paper 14, 3. Petitioner's motion for *pro hac vice* admission of Ms. Gordnia is *granted*.

In support of its motion for *pro hac vice* admission, Petitioner relies on the Declaration of Talin Gordnia (Exhibit 1014). Paper 14, 2. Petitioner, however, filed a document marked as Exhibit 1014 on May 9, 2016. As Petitioner notes, Petitioner "inadvertently submitted the [May 9, 2016 motion for *pro hac vice* admission of Ms. Gordnia] as the declaration in support of the motion" as Exhibit 1014 on May 9, 2016. Paper 14, 1; *see also* Paper 13, 2 ("The document filed as Exhibit 1014 is not the Declaration of Talin Gordnia, however, but instead is a copy of Petitioner's motion."). Given these circumstances, the copy of Exhibit 1014 filed on May 9, 2016 shall be expunged from the record.

It is

ORDERED that Petitioner's motion for *pro hac vice* admission of Ms. Talin Gordnia is *granted*;

FURTHER ORDERED that Ms. Gordnia is authorized to represent Petitioner as back-up counsel only;

FURTHER ORDERED that Ms. Gordnia is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Ms. Gordnia is subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO's Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq.*; and
