**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Gameloft, Inc. ("Petitioner") filed a petition for *inter partes* review of 41 claims of U.S. Patent No. 8,784,198 on August 19, 2015 (Paper No. 3). At the time of filing, Petitioner submitted a fee of \$32,800 consisting of a \$11,600.00 *inter partes* review request fee and a \$21,200.00 *inter partes* review post-institution fee in accordance with 37 C.F.R. § 42.15(a). Reg. 4212, 4234-35 (Jan. 18, 2013). Petitioner requests that the refund be deposited in Deposit Account No. 50-6159.
