Patent Owner has asserted the '506 patent, as well as two related family members, U.S. Patent Nos. 7,211,267 ("the '267 patent") and 7,232,572 ("the '572 patent"), in a civil action filed in the United States District Court for the District of Delaware (Civil Action No. 15-670) on July 31, 2015 against Petitioner.

The '267 and '572 patents were previously involved in a civil action filed by the Patent Owner in the United States District Court for the District of Delaware, including *Research Foundation of State Univ. of N.Y. v. Mylan Pharms., Inc.*, No. 09-cv-184-LPS (D. Del.); *Research Foundation of State Univ. of N.Y. v. Lupin Ltd. et al.*, No. 09-cv-483-LPS (D. Del.); *Research Foundation of State Univ. of N.Y. v. Impax Labs. Inc.*, No. 09-cv-703-LPS (D. Del.); *Research Foundation of State Univ. of N.Y. v. Sandoz Inc.*, No. 11-cv-162-LPS (D. Del.); and *Galderma Laboratories Inc. et al. v. Amneal Pharms. LLC et al.*, No. 11-cv-1106-LPS (D.

Del.). The Mylan Pharmaceuticals, Impax Laboratories, and Lupin Pharmaceuticals cases were appealed to the Court of Appeals for the Federal Circuit (No. 2012-1523 *et seq.*).

Apart from the captioned petition, Petitioner concurrently filed two other petitions for *inter partes* review of the same claims of the '506 patent, which petitions have been assigned nos. IPR2015-01777 and IPR2015-01778.

Lastly, a continuation application (Ser. No. 14/753,544) claiming priority to the '506 patent is currently pending.
