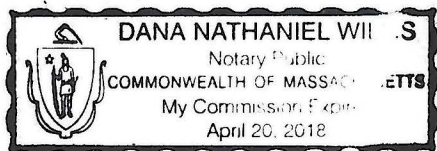
9. I have not previously applied to appear *pro hac vice* in a proceeding before the Office in the last three (3) years.
