A conference call was held on Tuesday, May 24, 2016, among Gregory Gonsalves, counsel for Petitioner; Cynthia Lambert Hardman, William James, and Nicholas Mitrokostas, counsel for Patent Owner; and Administrative Patent Judges Green, Tierney, and Obermann.
