4 EXAMINATION

5 BY MR. CASIERI:

6 Q. Good morning, Dr. Baillie.

7 A. Good morning, Mr. Casieri.

8 Q. I know you've had your deposition, so  
9 we'll keep this introduction brief. I just want to  
10 remind you that if you don't understand a question  
11 I ask or it's not clear, just let me know and I'll

23 you're unsure. I just essentially don't want to  
24 ask you each question today twice.
