 - a) Claims 1, 5, 7, 8, 10, and 11 as anticipated under 35 U.S.C. § 102(a) by Kisou;
 - b) Claims 5, 10, and 11 as unpatentable under 35 U.S.C. § 103(a) based on Kisou;
 - c) Claims 3 and 4 as unpatentable under 35 U.S.C. § 103(a) over the combination of Kisou and Yagi; and
 - d) . Claims 1, 3–5, 7, 8, 10, and 11 as unpatentable under 35 U.S.C. § 103(a) over the combination Furuya and Niizuma;
- 2. Any procedural and evidentiary issues raised by the parties;
- 3. Any additional issue the parties raise or propose to raise at or before the oral argument; and
- Any additional issues on which the Board seeks information or clarification.
 Petitioners request that they be permitted to argue first. Office Patent Trial
 Practice Guide, 77 Fed. Reg. 45,756, 48,768 (Aug. 14, 2012). Petitioners request

thirty minutes for its argument with the opportunity to reserve time for a rebuttal.
