3	JUDGE BOUDREAU: Good afternoon, everyone.
4	This is the oral hearing in case IPR2015-01892, captioned
5	Symantec Corporation versus Finjan, Incorporated, to which
6	case IPR2016-00890, captioned Blue Coat Systems,
7	Incorporated versus Finjan, Incorporated has been joined.
8	I'm Judge Boudreau, appearing from California.
9	There in Virginia you are joined by Judge Yang, and you
10	should see Judge Arpin on another screen there appearing
11	from Colorado.
12	Because of the limitations on our audio technology
13	Judge Arpin and I will only be able to hear you when you are
14	at the podium, so we ask that any time you are speaking,
15	please go to the podium and remain there.
16	Let's have each counsel come up and enter an
17	appearance and state your names for the record. We will start
18	with counsel for Petitioner, please.
19	MR. RICHETTI: Good afternoon, Your Honors.
20	Joseph Richetti from Bryan Cave on behalf of Petitioner.
21	With me is my associate, Alex Walden.

1	MR. HANNAH: Good afternoon, Your Honors.
2	James Hannah from Kramer Levin representing Finjan. And
3	with me is Michael Lee.
4	We also have Jeff Price. And Dr. Medvidovic is
5	also here if there are any questions for him during the
6	proceeding.
7	JUDGE YANG: Okay. Welcome to all.
8	JUDGE BOUDREAU: Thank you, counsel. Now,
9	we set out the procedure for today's hearing in our Revised
10	Hearing Order, which was Paper 50, but I will just take a few
11	minutes to remind you of how to proceed.
12	Petitioner and Patent Owner will each have 30
13	minutes of total time today to present their arguments. And
14	Petitioner will go first, present its case regarding the
15	challenged claims of the '494 patent and may reserve time for
16	rebuttal. Patent Owner may then respond to Petitioner's
17	presentation.
18	The fundamental rule governing our hearings is
19	that the party bearing the burden of persuasion on any issue
20	may speak last on that issue. So Petitioner will have the
21	opportunity to use any reserved rebuttal time to respond to
22	Patent Owner's arguments.
23	Also, because Patent Owner has filed a Motion to
24	Exclude Evidence in this case, which was Paper 41, and a
25	Motion for Observation on Cross-Examination of Petitioner's

1	declarant, Jack Davidson, that was Paper 42, Patent Owner
2	may also discuss both of those motions during its time. And
3	Petitioner may use a portion of its rebuttal time to respond to
4	Patent Owner's arguments regarding those motions.
5	But as stressed in the Hearing Order, Petitioner ay
6	only respond if Patent Owner actually raises those during its
7	presentation.
8	Just a few other points before we begin. First,
9	keep in mind that although I believe that you both requested
10	overhead projectors, Judge Arpin and I can't actually see the
11	screen from our remote locations. We both have copies of all
12	of the demonstratives and all of the papers in the case, so if
13	you are using the screen for Judge Yang's benefit, and you are
14	referring to any specific slide or figure in your
15	demonstratives, or any document in the record, we ask that
16	you just call out the slide number, figure number, or the
17	exhibit and page number so that the record is complete both in
18	the transcript, and so Judge Arpin and I can remotely follow
19	along.
20	Second, just as a common courtesy, if you believe
21	that the other party is arguing is presenting a new argument
22	in substance that wasn't presented in its briefs or if you have
23	any other objections, we ask that you just please wait until
24	your turn at the podium rather than interrupting opposing



counsel.
