Petitioners Symantec Corporation and Blue Coat Systems, Inc. (“Petitioner”) hereby requests oral argument pursuant to 37 C.F.R. §42.70(a). According to the Scheduling Order (Paper No. 10) entered on March 18, 2016, oral argument is currently scheduled for December 16, 2016. Petitioner specifies the following issues to be addressed:

1. The proper construction of certain claim terms under the broadest reasonable interpretation standard.
2. Whether claims 1, 2, 5, 6, 10, 11, 14, and 15 of U.S. Patent No. 8,677,494 are patentable over the asserted art and the grounds of unpatentability on which IPR2015-01892 was instituted.
3. Any issues specified by Patent Owner Finjan, Inc. in its Request for Oral Argument.
4. Any other issues that the Board deems necessary for issuing a final written decision.

Petitioner requests that the Board provide audio-visual equipment to display demonstrative exhibits, including the use of an overhead projector and screen for displaying documents.
