**PETITIONER'S OBJECTIONS TO PATENT OWNER'S  
DEMONSTRATIVE EXHIBITS**

Petitioner Emerson Electric Co. hereby makes the following objections to Patent Owner's demonstrative exhibits served on October 19, 2016.

Slides page 2 – Objection: Mischaracterization. Bullet 2: the word “remote” is not stated or implied in the cited section

Slide page 3 – Objection: Argumentative language suggests invention based on the abstract rather than claims, misquotes the citation, and the introductory language suggests a broader application than the actual language: “Embodiments of the present invention are directed to a [system...]

Slide page 5 – Objection: Mischaracterizes/misquotes language: Bullet 1: The demonstrative quotes from a section referencing Fig. 3A, which is an embodiment “worn or carried by a person” (8:19); no mention of “integrated transceivers.”

Slide page 5 – Objection: Mischaracterizes/misquotes language: Bullet 2: same problem as Bullet 1 (no reference to integrated transceivers) and the quote lops off the introduction identifying the actual instrumentality: “The data formatter 324 operates to [format a packet with]...”

Slide page 5 – Objection: Mischaracterizes/misquotes language: Bullet 3: Argumentative introduction; the real intro to the quoted language is “The data controller 324 [assembled a packet]...”

Slide page 5 – Objection: Mischaracterizes/misquotes language: Bullet 4: The quote is misjoined to Bullets 1-3 because it relates to a specific parking lot embodiment (not, for example, the transmitter worn or carried on a person (bullets 1 and 2).

Slide page 6 – Objection: Bullet 2 is improperly argumentative.

Slide pages 7 through 11 – Objection: All bullet points are argumentative; mischaracterize arguments as “issues.”

Slide page 7 – Objection: Misquotes the language of claims 17 and 18 – adding elements not claimed.

Slide page 8 – Objection: Misquotes the language of claim 29 – adding elements not claimed.

Slide page 9 – Objection: Mischaracterizes the claim language, the characterizations do not appear in their entirety in any of the independent claims, for example: none of the independent claims have not the language “its own [ID]” and independent claim 26 recites very little of the characterized language.

Slide page 10 – Objection: Misquoting claim language, the alleged quote is not “similarly recited” in claim 29.

Slide page 12 – Objection: Argumentative, mischaracterizes the claims at issue since it illustrates only one specific “home heating system” embodiment of the function codes (col. 10, line 47).

Slide pages 14, 15 – Objection: Argumentative and mischaracterizes the language of claims 17 and 18.

Slide pages 16-17 – Objection: Argumentative/Mischaracterizes the language of claim 29.

Slide page 18 – Objection: Argumentative, Sub-bullet 1: Mischaracterizes claim 20, Sub-bullet 2: Mischaracterizes claim 28.

Slide pages 19 through 28 and 32-35 – Objection: Argumentative.

Slide page 22 – Additional Objection: Bullet 1: Mischaracterizes the language of the independent claims.
