The Bd. of Regents of the Univ. of Michigan*, IPR2013-00041, Paper 65 at 2-3 (Jan. 27, 2014) (“[E]xhibits cannot add new evidence to the record of the proceeding.”); F.R.E. 402, 403. Petitioner further objects that the evidence discussed in slide 20 is inadmissible hearsay. F.R.E. 802.
