Petitioners Command Web Offset Company, Inc., Worzalla Publishing Company, Sandy Alexander, Inc., Publication Printers Corp., Specialty Promotions, Inc., and Trend Offset Printing Services Inc. On October 2, 2015, Petitioners filed a Petition for *inter partes* review of U.S. Patent No. 6,611,349. As required by 37 C.F.R. § 42.15(a), Petitioners deposited \$23,000.00 with the USPTO at the time of filing the Petition to cover associated fees. Petitioners' payment consisted of \$9,000.00 in fees associated with the request for *inter partes* review, and a further \$14,000.00 in post-institution fees.

On March 28, 2016, the Board issued an Order denying institution. (Paper 13.) On April 27, 2016, Petitioners timely requested rehearing of the Board's Order denying institution. (Paper 14.) Petitioners' rehearing request remained pending as of August 2, 2018, when Petitioners filed a motion to withdraw their rehearing request. (Paper 15.) The Board granted Petitioners' motion to withdraw on August 21, 2018. (Paper 16.) Accordingly, Petitioner requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$14,000.00, to be paid to deposit account number 15-0030.
