("Headway"), a supplier to Toshiba of products accused of infringement in the Pennsylvania Action, filed an action seeking a declaration of non-infringement of the '988 Patent for components included in the accused products in the Pennsylvania Action in the United States District Court for the Central District of California. *See Headway Technologies, Inc. v.
