

**Claim 1:**

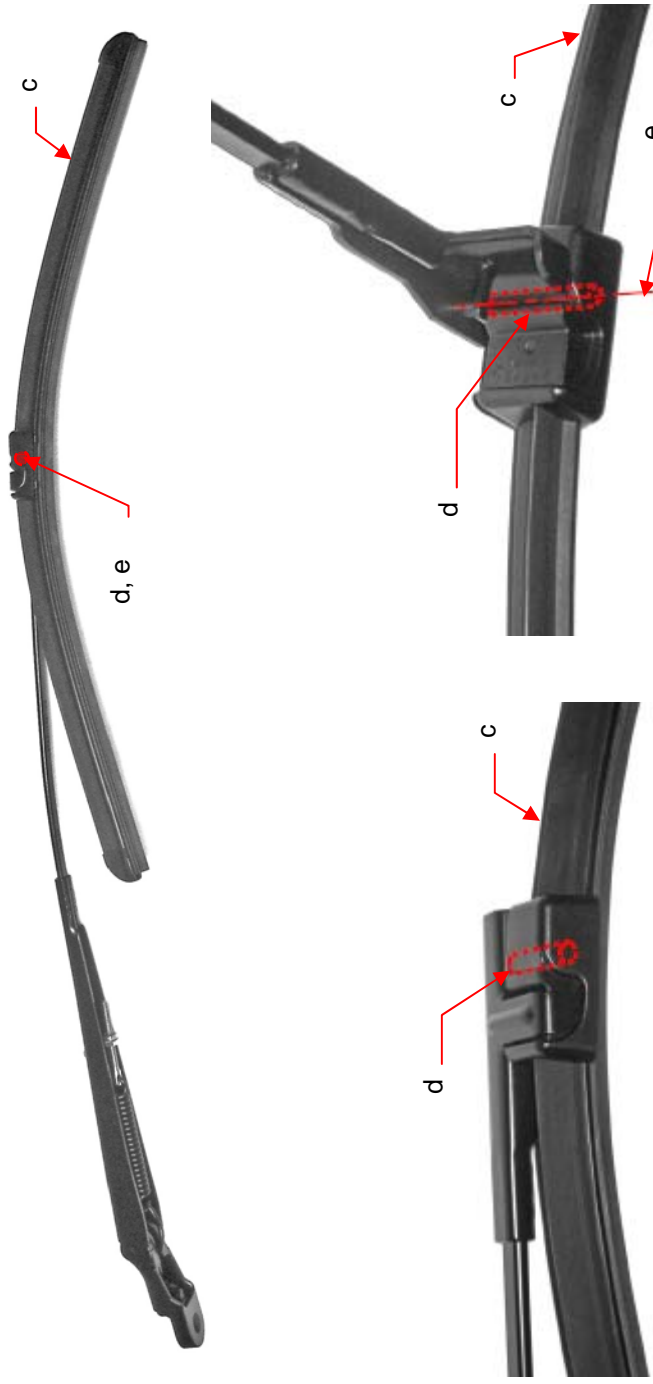

**Claim Element**

on said joint pin being mounted a wiper blade (14) capable of swinging about the joint axis (55), said blade having spaced sides with said arm lying on one of said sides

**Bosch OE Wiper Blade**

The wiper apparatus is characterized in that on the joint pin (d) a wiper blade (c) is mounted, capable of swinging about the joint axis (e), the wiper blade having spaced sides with said arm lying on one of said sides.

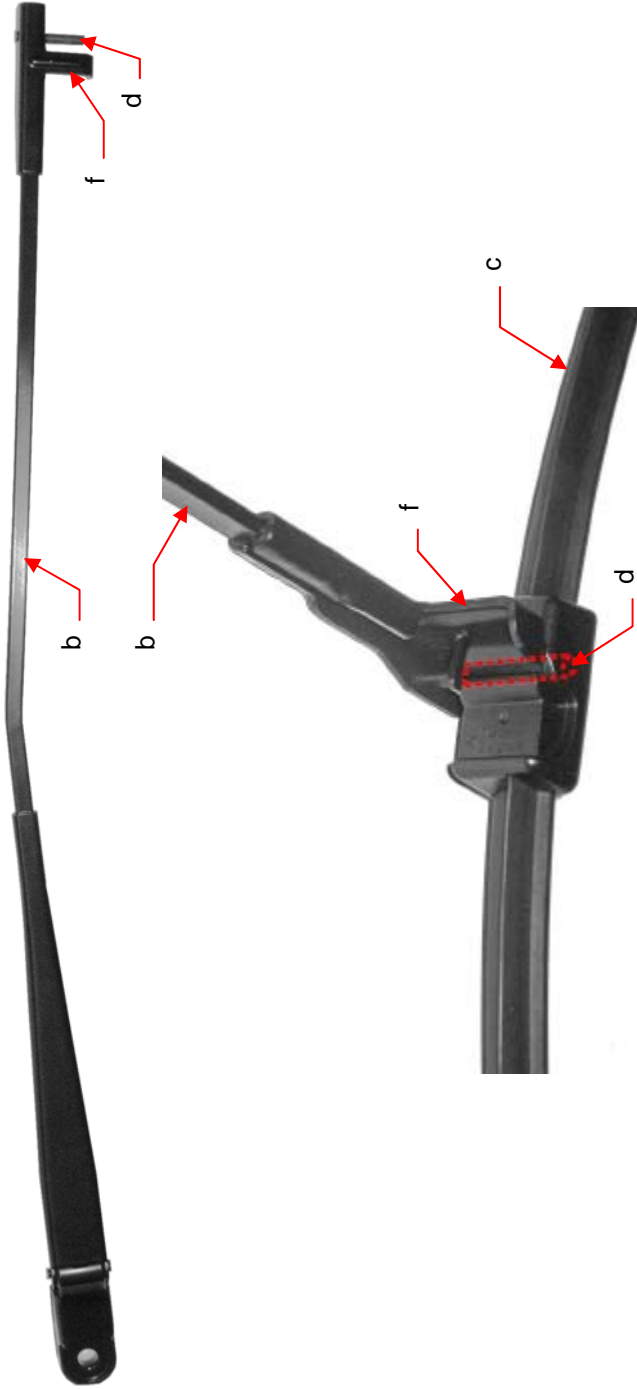


**Claim Element**

the wiper apparatus having means for securing the wiper blade on the joint pin (56), characterized in that the securing means (60) are disposed on the wiper arm (12) and extending therefrom

**Bosch OE Wiper Blade**

The wiper apparatus is characterized in that it has means (f) for securing the wiper blade (c) on the joint pin (d), characterized in that the securing means (f) are disposed on the wiper arm (b) and extending therefrom.
