


**Claim 1:**

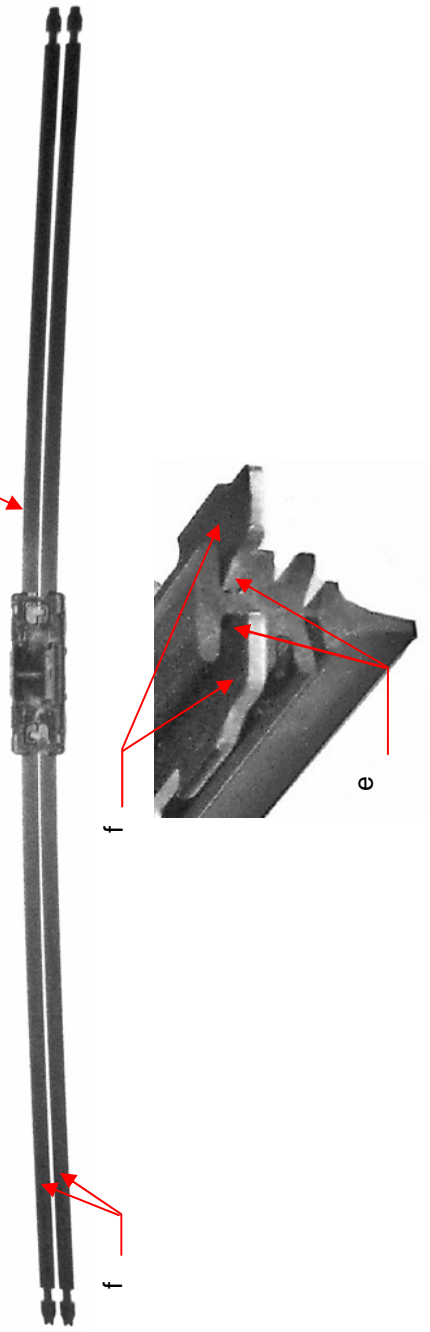

<p>An elongated wiper blade (10) for windows of motor vehicles, having</p>	<p>The Bosch ICON wiper blade is an elongated wiper blade for windows of motor vehicles.</p> 
<p>an elastic, elongated support element for an elongated wiper strip (22), which strip comprises a flexible material and can be placed against the window to be wiped with a wiper lip (30)</p>	<p>The wiper blade has an elastic, elongated support element (a) for an elongated wiper strip (c), which strip comprises a flexible material and can be placed against the window to be wiped with a wiper lip (d).</p> 

**Claim Element**

and which on its long sides has opposed longitudinal grooves (34), in which spaced-apart longitudinal rails (32) of the support element (12) are located,

**Bosch ICON Wiper Blade**

The wiper blade is characterized in that the wiper strip on its long sides has opposed longitudinal grooves (e), in which spaced-apart longitudinal rails (f) of the support element (a) are located.

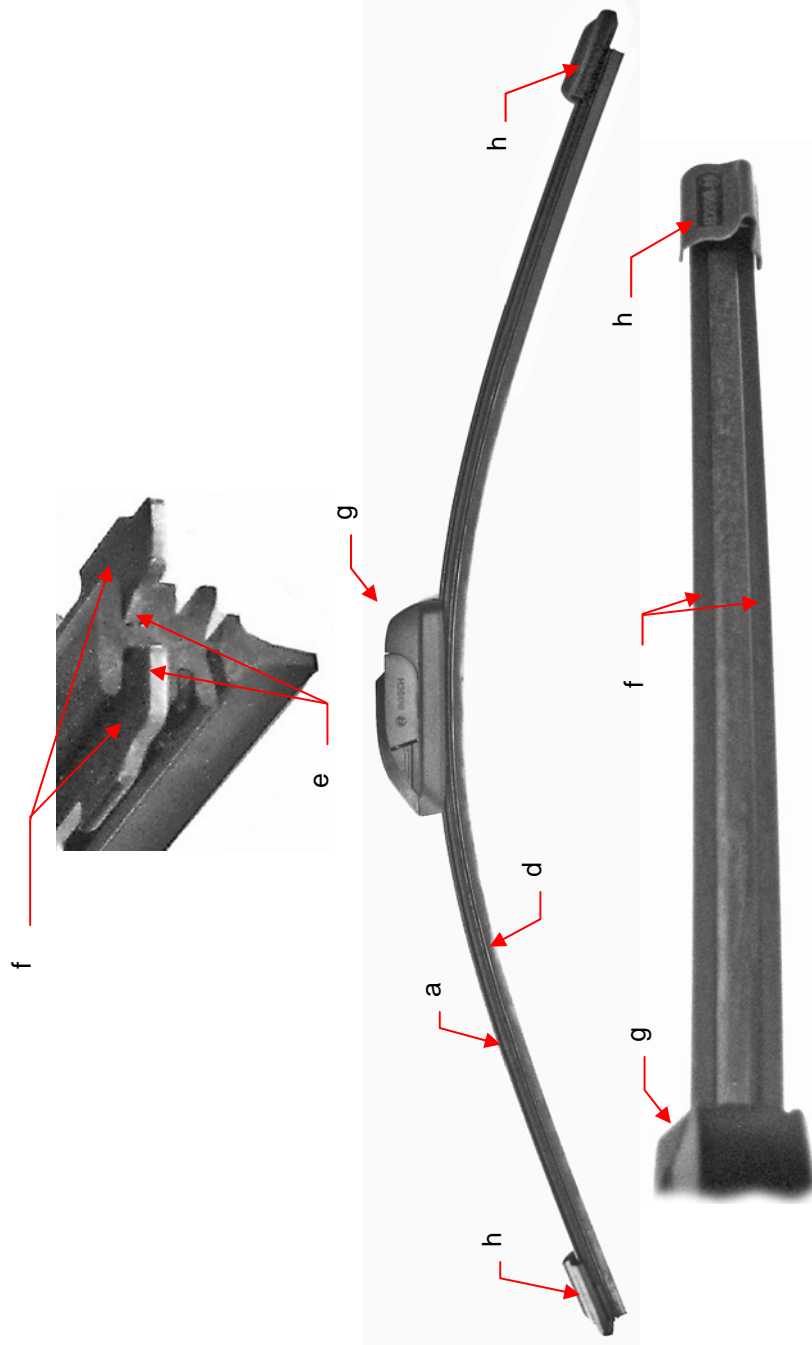


**Claim Element**

which rails are secured in the grooves (34) by at least one retainer (36, 38, 40) that spans a spacing between sides of the support element (12) remote from the wiper lip (30),

**Bosch ICON Wiper Blade**

The wiper blade is characterized in that the rails (f) are secured in the grooves (e) by at least one retainer (g, h) that spans a spacing between sides of the support element (a) remote from the wiper lip (d).
