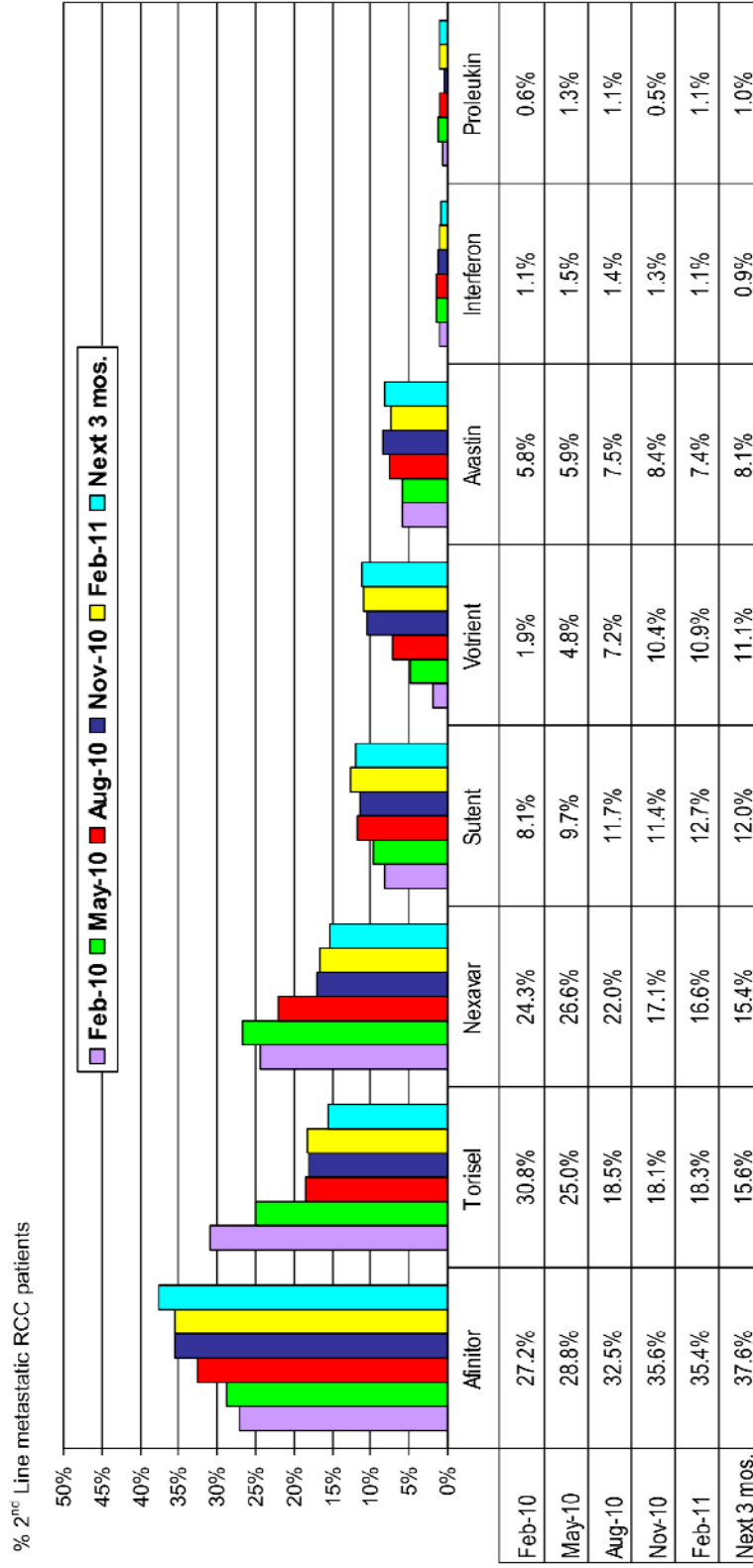

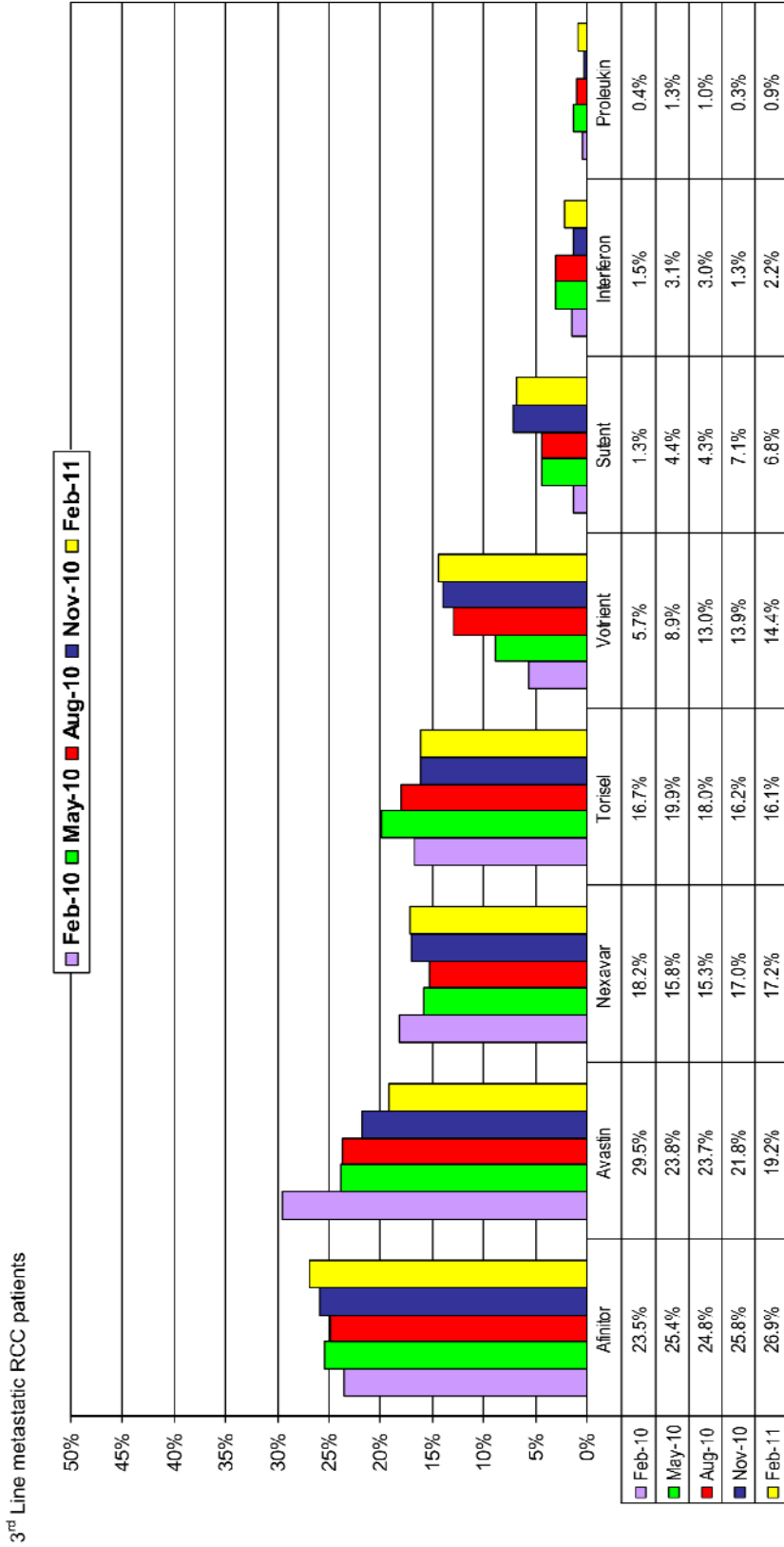


Q9. Of your **metastatic** RCC patients that receive **2nd line** drug therapy, how many received each agent below, alone or in combination with other therapy?

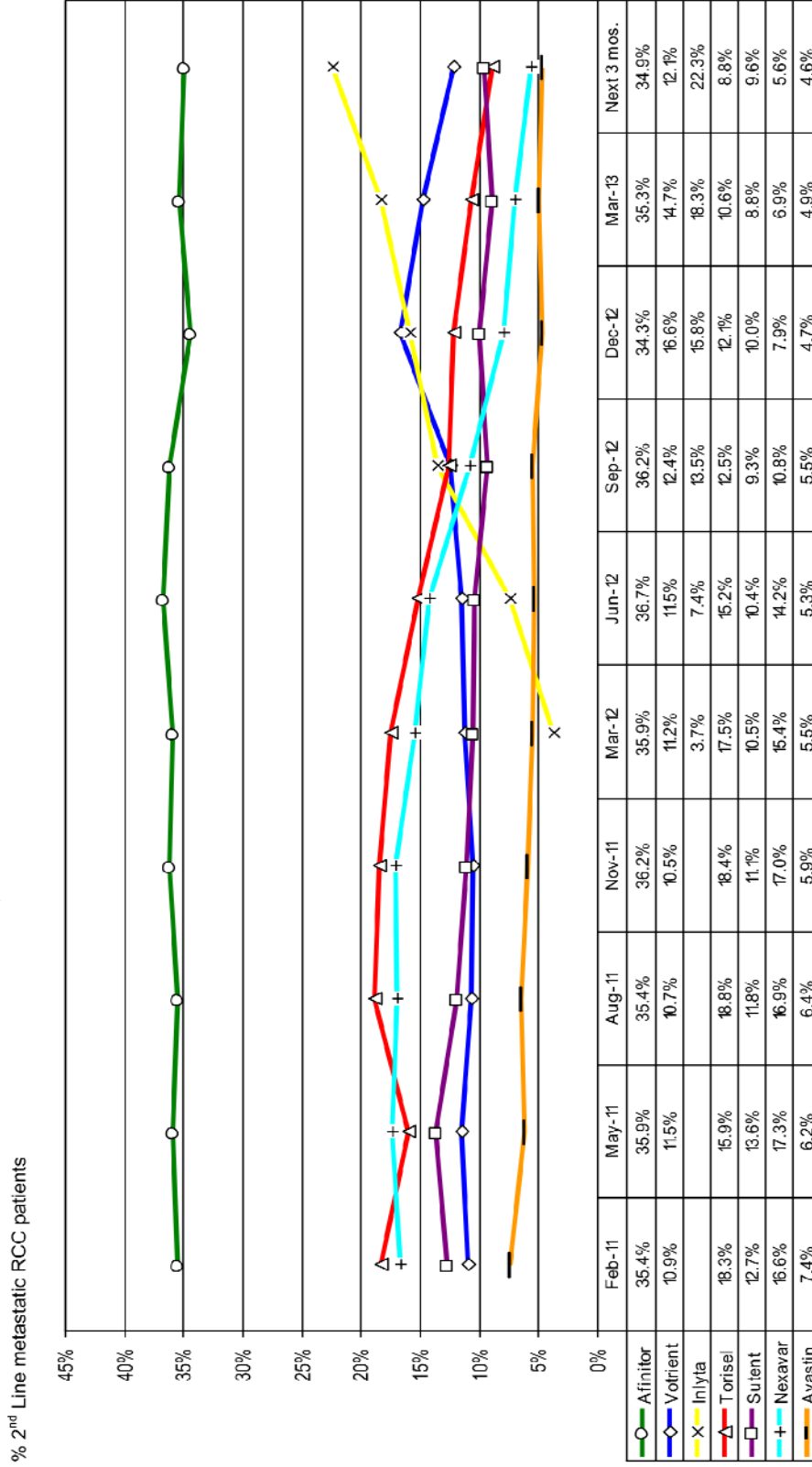
