PETITIONER'S REQUEST FOR ORAL ARGUMENT



Pursuant to 37 C.F.R. § 42.70(a), Petitioner submits this Request for Oral Argument on the newly instituted grounds of unpatentability for claims 9 and 12 of U.S. Patent No. 8,141,154 (*see* Order – Conduct of the Proceeding (Paper 55) at 2). Petitioner will address the following issues:

- 1. Petitioner is not estopped under 35 U.S.C. §315(E)(1) from addressing the patentability of claims 9 and 12, because there is no final written decision with respect to those claims.
- 2. The Board should address the merits of Petitioner's arguments with respect to claims 9 and 12, despite the Board's determination that claims 6 and 10 (from which 9 and 12 depend) are patentable.
- 3. Claims 9 and 12 are rendered obvious under 35 U.S.C. §103 over Ross (U.S. Patent Publication No. 2007/0113282, "Ross") in view of Calder (U.S. Patent Publication No. 2002/0066022, "Calder.")

The Board has already scheduled Oral Argument for March 26, 2019. (Order (Paper 56) at 5).
