INTRODUCTION

Palo Alto Networks, Inc.’s appeal stems from the Patent Trial and Appeal Board’s Final Written Decision on Remand entered on May 15, 2019 (Paper 68) (the “Final Written Decision on Remand”) in the above-captioned *inter partes* review of United States Patent No. 8,141,154 B2 (“the ’154 patent”). PALO ALTO NETWORKS INC.’S ISSUES ON APPEAL

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Palo Alto Networks, Inc.’s issues on appeal include at least the Board’s determination that Petitioners did not establish that claims 1-12 of the ’154 patent are unpatentable under 35 U.S.C. §103 in view of the grounds of unpatentability on which trial was instituted (*see* Papers 10, 51, 55, and 68) and any findings or decisions related to that determination adverse to Palo Alto Networks, Inc.
