Pursuant to 35 U.S.C. § 317 and 37 C.F.R. § 42.74, Petitioner WTS Paradigm, LLC, and Patent Owner EdgeAQ, LLC, jointly request termination of the *inter partes* review of U.S. Patent No. 7,805,461 ("the '461 Patent"), Case No. IPR2016-00199.

In November 2015, Petitioner filed a petition for *inter partes* review of the '461 Patent, and the Board subsequently granted that petition and instituted review. Pursuant to a June 22, 2016, written settlement agreement (a copy of which is filed concurrently herewith), Petitioner and Patent Owner have now resolved all issues relating to their dispute.
