**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On November 25, 2015, Petitioners Hyundai Motor America, Inc., Hyundai Motor Company, Kia Motors Corporation and Kia Motors America, Inc. (“Petitioners”) filed a petition for *inter partes* review (“IPR”) challenging claims 1–3, 6–12, 16, 17, 19, 23, 27, 30, and 66 in U.S. Patent No. 7,237,634. In challenging these 17 claims, Petitioner prepaid \$14,000 for the post-institution fee (for up to 15 claims) and \$800 for the 2 claims in excess of 15 (\$400 for each excess claim). The parties settled their dispute and filed a joint motion to terminate this proceeding on December 22, 2015. *See* paper 11. The Board granted the motion and terminated this proceeding pursuant to its decision on January 7, 2016. This proceeding was terminated prior to institution of trial. *See* paper 13.

Because the IPR petition was not instituted, Petitioner respectfully requests a refund of \$14,800 for the post-institution fee that was prepaid. The filing fee was paid by Deposit Account No. 02-4467. Accordingly, Petitioner requests that the amount of \$14,800 be refunded to Deposit Account No. 02-4467.
