Petitioner Teva Pharmaceuticals USA, Inc. filed three petitions tonight, assigned case numbers IPR2016-00280; IPR2016-00281; and IPR2016-00282. During the course of the filing, Petitioner encountered several serious PRPS technical errors, primarily involving file uploading and the credit card payment system. PRPS crashed several times and would not accept payments. Petitioner attempted, for example, to submit credit card payments (using several different credit cards) through two separate PRPS accounts (for Eleanor Yost and Elizabeth Holland), which were all declined. Petitioner ultimately was able to pay using a credit card, but the technical issues delayed the overall submission of Petitioner's documentation package in each case.
