Pursuant to the Board's June 6, 2016 Scheduling Order (Paper 10) and 37 C.F.R. § 42.70(a), Patent Owner MD Security Solutions LLC ("MD Security") hereby requests oral argument on (1) whether claims 1-8, 11, and 18-20 of the '983 patent are unpatentable as obvious over Milinusic² and Osann,³ (2) whether claims 9, 10 and 12–17 are obvious over Milinusic, Osann, and Ozer,⁴ and all other matters raised in the Institution Decision (Paper 9).
