PETITIONER'S REQUEST FOR ORAL ARGUMENT

Petitioner respectfully requests oral argument in connection with IPR2016-00387 for U.S. Patent No. 8,841,778 (“the ’778 Patent”). Pursuant to 37 C.F.R. § 42.70, Petitioner specifies the following issues to be argued:

- Grounds for which *inter partes* review was instituted for the ’778 Patent and any issue raised in the Board’s Institution Decision;
- Any issue addressed in Petitioner’s papers, including but not limited to the Petition and Petitioner’s Reply Brief;
- Rebuttal to Patent Owner’s presentation on all issues, including the issues identified above and any issues raised in Patent Owner’s Response and exhibits cited therein;
- Any issues raised by the Board or Patent Owner at oral argument;
- Any other issues raised in papers filed in this proceeding, including issues raised in papers yet to be filed; and
- Any other issues that the Board deems necessary for issuing a final written decision.

The oral hearing for this case and IPR2016-00386, -00388, -00389, -00390, -00391, -00393, and -00395 is currently scheduled for April 5-7, 2017. Given the commonality of issues between proceedings, the parties emailed the Board on February 24, 2017, jointly requesting that the oral hearing for the following closely-related proceedings be consolidated with this hearing such that the oral

hearing for all 14 proceedings occurs on April 5-7, 2017: IPR2016-00687 and -00691 (oral hearing currently set for May 31, 2017), and IPR2016-00708, -00770, and -00786 (oral hearing currently set for June 29, 2017). Petitioner requests half of the time that the Board determines is appropriate for oral argument and believes that, whether or not consolidated, each side needs no more than three hours (six hours total) to present arguments and respond to the Board's questions. Petitioner additionally requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a monitor or projector to be connected to a laptop, a screen, and an ELMO for displaying documents of record.
