Google 2004 Acquisitions

According to Google's Annual 10-K Report, the Company made a total of 4 acquisitions in 2004 :



a photo organizer company



a digital mapping company



a traffic/mapping company

an Australian mapping company

- Total consideration for these companies was \$56 million
 - \$22 million in cash and \$34 million in stock

Acquisition Deal Metrics

Keyhole Estimated Deal Terms

- Based on a review of the Company's other acquisitions, along with the quarterly cash flow (investing) statements, Google spent approximately \$11 million in cash on the Keyhole acquisition
- Additionally, in October 2004, Google issued 122,997 shares of common stock worth an aggregate value of \$17.44 million at issuance
- In the Notes to Consolidated Financial Statements, Google mentioned a \$10 million cash earnout to certain former employees of an acquired company contingent upon their continued employment and their attainment of certain performance milestones
 - Given the initial consideration of Keyhole vs. other acquisitions, it can be assumed to be part of the Keyhole transaction
- Total Estimated Deal Value of \$38.44 million, including the earnout
