Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a)(1), that Patent Owner Bradium Technologies LLC ("Patent Owner" or "Bradium") hereby timely appeals under 35 U.S.C. §§ 141, 142, and 319 to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on July 26, 2017 (Paper No. 67), and from all underlying orders, decisions, rulings, and opinions.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Bradium states that the issues for appeal include, but are not limited to: (i) whether the Board erred in finding claims 1–21 of U.S. Patent No. 8,924,506 unpatentable; (ii) whether *inter partes* review proceedings violate the Constitution by extinguishing private property rights through a non-Article III forum without a jury; (iii) whether the Board violated Bradium's due process rights, acted in an arbitrary or capricious manner and/or exceeded its authority, or otherwise erred in instituting the IPR2016-00449 *inter partes* review proceeding after denying institution of IPR2015-01435 based on a petition by the same Petitioner Microsoft.
