Mercedes-Benz USA, LLC (“Mercedes” or “Petitioner”) filed its Petition for *inter partes* review of U.S. Patent No. 7,241,034 on January 26, 2016. (Paper 1.) Subsequently, Mercedes and Advanced Headlamp Technologies, Inc. (“AHT”) resolved their dispute through settlement and Mercedes filed a Motion to Terminate the proceedings. (Paper 8.)
