## I. ANALYSIS

Pursuant to our authorization, on November 18, 2016, Petitioner filed a Motion to Authorize Withdrawal of Counsel. Paper 34 (“Motion” or “Mot.”). AMX, LLC (“AMX”) was terminated from this proceeding as a result of a settlement agreement between AMX and Patent Owner. Mot. 1 (citing Papers 29, 32). Specifically, the Motion seeks authorization for withdrawal of AMX’s lead counsel Brent Hawkins and back-up counsel Amol Parikh. Mot. 1. In an email to the Board on November 30, 2016, Patent Owner indicated that it does not oppose the Motion.

Messrs. Hawkins and Parikh were also counsel for Dell, Inc. (“Dell”) pursuant to a power of attorney filed February 29, 2016. Paper 2. An amended power of attorney was filed on November 18, 2016, naming Gilbert A. Greene, James G. Warriner, and Stephanie N. DeBrow as Dell’s counsel. Paper 33.

## II. ORDER

In consideration of the foregoing, it is hereby  
ORDERED that Petitioner’s Motion is *granted*;  
FURTHER ORDERED that Brent Hawkins and Amol Parikh are  
permitted to withdraw as counsel in this proceeding.
