**PETITIONER'S REQUEST FOR  
REFUND OF POST-INSTITUTION FEES**

Petitioner Umicore AG & Co. KG (“Umicore” or “Petitioner”) filed its Petition for *Inter Partes* Review (“IPR”) in this case on February 17, 2016. The petition identified all 27 claims of U.S. Patent No. 9,039,982 as the claims at issue. (See Paper 1.) On August 31, 2016, and prior to issuance of an institution decision, the Board granted a joint motion to terminate and dismiss the IPR petition in view of a settlement between Petitioner and Patent Owner BASF Corp. (See Paper 9.)

Since Umicore’s petition addressed 27 claims, it was accompanied by a fee payment of \$27,400 that can be broken down as follows:

IPR Request fee (37 CFR § 42.15(1))	\$9,000
Fee for claims in excess of 20 in petition (37 CFR § 42.15(3))	\$1,400 (7 claims x \$200)
IPR Post-Institution fee (37 CFR § 42.15(2))	\$14,000
Fee for instituted claims in excess of 15 (37 CFR § 42.15(4))	\$4,800 (12 claims x \$400)
<b>TOTAL</b>	<b>\$29,200</b>

In view of the dismissal of the IPR petition prior to institution, Petitioner respectfully requests a refund of in the amount of **\$18,800**. This amount includes

the post-institution fee and the fee for instituted claims in excess of 15. Petitioner requests that the refund be credited to the deposit account of Orrick, Herrington, & Sutcliffe LLP: 15-0665.
