IntelGenX Corporation ("Petitioner") filed a Petition to institute an *inter partes* review of claims 1–12 of U.S. Patent No. 6,943,166 B1. On September 1, 2016, we denied the Petition. Paper 13 ("Dec."). On October 3, 2016, Petitioner filed a Request for Rehearing under 37 C.F.R. §42.71. Paper 14.

ICOS Corporation ("Patent Owner") is hereby authorized to file a responsive brief. The brief shall not exceed ten pages in length, and is limited to addressing Petitioner's argument that:

[B]ecause the SNDA taught "single doses" per day, Petition at 41, the unit dosage and the maximum daily total were <u>one and the same</u> in the SNDA. Thus, the Petitioner pointed to the size of the "single" dose in the SNDA to account for <u>both</u> the unit dose <u>and</u> the maximum total dose per day.

Id. at 10. Patent Owner is not authorized to file additional supporting evidence, such as declaratory testimony, with the brief.

Accordingly, it is

ORDERED that Patent Owner is authorized to file a brief in response to Petitioner's Request for Rehearing;

FURTHER ORDERED that the brief shall not exceed ten pages in length and must be filed within ten business days after entry of this Order;

FURTHER ORDERED that no additional supporting evidence is authorized with the brief; and

FURTHER ORDERED that no further briefing is authorized at this time.
